The Guaranteed Irish Sustainability Roadmap

provides a structured approach to integrating Environmental, Social, and Governance (ESG) principles into business operations. It guides Guaranteed Irish members through three stages—Foundation, Implementation, and Leadership—supporting them in building more sustainable, future-ready supply chains.



The Guaranteed Irish Sustainable Leaders Programme

translates the roadmap into a hands-on learning experience. Delivered in partnership with sustainability platform ENSO, it equips members with the tools, training, and expert support needed to implement meaningful sustainability strategies—strategies that meet regulatory requirements and strengthen supply chain credibility. Participants will develop a tailored sustainability roadmap for their business, track progress through key metrics, and collaborate with peers navigating similar challenges. With a focus on practical outcomes and real-world application, this programme empowers businesses to turn sustainability into a strategic supply chain advantage.

Programme Details

Start Date: September 2025

Duration: 6 Months

Location: Hybrid (Online/Dublin)

Participants: Up to 3 participants per company. This programme is for individuals responsible for delivering on sustainability, regardless of prior ESG knowledge.

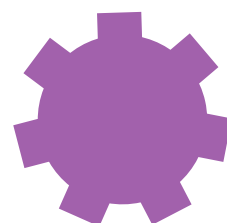
